This book provides guidelines for how to make judgments about which medium to access and when to access it. In the second edition, these judgments are illustrated throughout each research topic to better evidence how practitioners use both print and online sources on the same project. For a practitioner, Missouri Legal Research provides a one-stop source, succinct in its presentation of all Missouri legal resources. A thorough, but concise, explanation of primary and secondary authority gives the researcher a reference to consult when researching resources that one only uses occasionally, such as Missouri and federal legislative history and administrative law. Missouri Legal Research includes a thorough explanation of citation using either The Bluebook: A Uniform System of Citation or the ALWD Citation Manual: A Professional System of Citation.
