In all questions of injunction in aid of legal rights, whether it be of copyright, whether it be of patent, or of various other descriptions of legal rights, which come indirectly before the consideration of this Court, the office of the Court is consequential upon the legal right, and it generally happens, that the only question the Court has to consider is, whether the case be so clear and so free from objection upon the grounds of equitable considerations, that the Court ought to interfere by way of injunction, without a previous trial at law, or whether the Court thinks it expedient, under the circumstances of each case, to abstain from exercising its jurisdiction until the legal title be established. That distinction depends on a great variety of circumstances; and it is utterly impossible to lay down any general rule, by which the discretion of the Court ought, in all cases, to be regulated.
